Prettl group takes over Microtherm group

Pforzheim/Pfullingen, 09.10.2020 - The Prettl group is taking over the entire business operations of Microtherm GmbH in Pforzheim, as well as the subsidiaries in the Czech Republic, China and India, as part of an asset deal. The purchase agreement was notarized on 08.10.2020. As usual, the actual takeover is still subject to official approvals and other agreements and is scheduled for 1st December.

"With the acquisition of Microtherm, we intend to establish a competitive, technologically oriented location in the Pforzheim region for the long term. In the future, Prettl will introduce its specific process expertise in the field of high precision, thermally sensitive and sensor products to the Microtherm Group. We will also expand the Prettl Group's engineering and development services in the automotive and industrial applications sector in a targeted manner," states the main persons responsible at Prettl for the investment, thereby simultaneously describing the strategic outlook for Microtherm in the Prettl Group.

By taking over the insolvent manufacturer of components for temperature control, as well as temperature and motion sensor technology, Prettl is securing the continuation of its business operations in Pforzheim and its three international sites in the Czech Republic, China and India. As part of the necessary customer-oriented further development and restructuring, new jobs will also be created in engineering and sales.

"The now achieved investor solution is an excellent result in view of the difficult accompanying circumstances and the consequences of the Corona crisis. This is particularly true with regard to the preservation of jobs and locations. The prerequisite was that we were able to maintain operations at Microtherm since the insolvency filing in April 2020 with the strong support of customers, suppliers and employees. This made it possible for us to set up an investor process for a company that continued to perform well, and ultimately to reach a happy end", states the insolvency administrator and restructuring expert Marc Schmidt-Thieme (Hoefer Schmidt-Thieme law firm) and the management of Microtherm GmbH.

Microtherm produces at four locations with around 200 employees. Microtherm GmbH filed for insolvency

proceedings on April 16, 2020. The lawyer Marc Schmidt-Thieme from the law firm Hoefer Schmidt-Thieme was

appointed as insolvency administrator. Thanks to a positive order situation, he was initially able to continue the

business operations together with the management, while a solution for continuation was sought.
